*UNTSO was the first peacekeeping operation established by the Security Council, in its resolution 50 (1949), and continues to represent the commitment of the Council to assist in the implementation of the 1949 Armistice Agreements and their attendant ceasefires. In its resolution 73 (1949), the Council requested the Secretary-General to arrange for the continued service of such UNTSO personnel as might be required in observing and maintaining the ceasefire, as requested by the Council in its resolution 54 (1948), and as might be necessary in assisting the parties to the Agreements in the supervision of the application and observance of the terms of those Agreements. UNTSO is mandated to observe and maintain the unconditional ceasefires and assist the parties to the 1949 Armistice Agreements in the supervision of the application and observance of the terms of those Agreements. Its mandate derives from Security Council resolutions and decisions, including foundational resolutions 50 (1948), 54 (1948), and 73 (1949). UNTSO's activities are spread over Egypt, Israel, Jordan, Lebanon and the Syrian Arab Republic to maintain the regional liaison architecture established under the Armistice Agreements.*

### **Responsibilities**

Under the overall direction of the Chief Transport Unit and within delegated authority, the Vehicle Technician will be responsible for the following duties

- Services and repairs standard civilian pattern commercial vehicles in accordance with vehicle manufactures standards
- Ensures that all relevant safety procedures have been followed when repairing and fitting replacement parts
- Conducts vehicle inspections such as pre-summer and winter inspections on UN-owned vehicles assigned to various units.
- Produces reports to document all servicing and repairs.
- Assists in identifying, diagnosing and rectifying various faults.
- Assists with the identification of required parts
- Assist with training and coaching of mechanics within his/her expertise.
- Carries out any other duties assigned by the supervisor or by the Head of Unit/Section.

### **Competencies**

**Professionalism** – Knowledge of practices and procedures of large volume transportation operations in the field. Knowledge of regulations and requirements designed to ensure the safety of Ground Transportation Vehicles. Ability to estimate the extent of damage or value of items lost in transit and to prepare claims documents and negotiate adjustments with representatives of insurance agencies or others involved in losses or damages. Ability to conduct research, evaluate and integrate information from a variety of sources, to assess impact on transport operations. Shows pride in work and in achievements; demonstrates professional competence and mastery of subject matter; is conscientious and efficient in meeting

commitments, observing deadlines, and achieving results; is motivated by professional rather than personal concerns; shows persistence when faced with difficult problems or challenges; remains calm in stressful situations. Commitment to implementing the goal of gender equality by ensuring the equal participation and full involvement of women and men in all aspects of work. **Communication** – Speaks and writes clearly and effectively; listens to others, correctly interprets messages from others and responds appropriately; asks questions to clarify, and exhibits interest in having two-way communication; tailors language, tone, style and format to match audience; demonstrates openness in sharing information and keeping people informed. **Planning & Organizing** – Develops clear goals that are consistent with agreed strategies. Identifies priority activities of assignments. Allocates appropriate amount of time and resources for completing work. Foresees risks and allows for contingencies when planning. Uses time efficiently.

## Education

High school diploma or equivalent. College certificate for Motor vehicle Technician (National Certificate or equivalent) is required

## Work Experience

At least three (03) years of progressively responsible Transport Operations experience in Motor vehicle repairs and maintenance is required.

## Languages

Fluency in spoken and written English is required. Fluency in the local languages (Arabic and/or Hebrew) is desirable.

NOTE: "Fluency" equals a rating of "fluent" in all four areas (read, write, speak, understand) and "Knowledge of" equals a rating of "confident" in two of the four areas.

## Other Skills

Valid clean B-Class national driving license is required, any other class is desirable

## Assessment Method

Short-listed applicants may be evaluated through a competency-based interview and/or other assessment methods.

1. To start the application process, applicants must download a [Personal History "P.11"](#) form. **Note: Any other form of application will not be accepted.**
2. Once the download is finished, complete and save your Personal History Form (P.11) and then e-mail it to the following e-mail address: [untso\\_staffing@un.org](mailto:untso_staffing@un.org)
3. In completing the P.11 form, please note that all fields must be completed accurately to the best of your knowledge.
4. Submit a written cover-page application in addition to your completed and signed P.11 form.
5. Indicate the JO number on the subject heading in your email application. Applications that do not comply to this standard will not be validated.
6. Your application will be screened and evaluated against the requirements as specified in the particular vacancy and your name may be put forward for that specific announcement only.
7. In view of the high volume of applications received, only those applicants who move forward in the process, will be contacted for further assessment. Those who are successful/not successful in the assessment will be notified.
8.
