Special Notice

The temporary position is intended to fill the functions for a short-term duration with a possibility of extension subject to the availability of the position. Recruitment for this position is done on a local basis, whether or not the candidate is a resident of the duty station. Candidates should have no expectation of any fixed-term appointment possibility after the end of this temporary assignment. Subsequent to the initial temporary appointment, new and successive temporary appointments may be granted for service in the same office or in a different office any number of times, for any duration, provided that the length of service does not exceed the period of 364 calendar days.

Responsibilities

Under the direct supervision of the Budget Officer, and overall guidance of the Chief, Financial Resourcing & Performance Section, the incumbent will provide accurate and timely support to the development of budget proposals and administration of approved budget including accurate recording of financial transactions. The incumbent will perform the following functions:

- 1. Provides support to the Strategic Resourcing Unit focusing on achievement of the following results:
 - Assists in preparation of supporting documents (narrative and supporting tables) with respect to finalization of cost estimates and budget proposals;
 - Assists funds center managers in the elaboration of resource requirements for budget submissions, for staff and nonstaff requirements;
 - Assists in preparation of budget performance submissions and finalization of budget performance reports, analyzing variances between approved budgets and actual expenditures;
 - Assists and processes the mission redeployment of fund requests in accordance with the established procedures;
 - Supports the monitoring of budget implementation/expenditures with approved budget in ensuring they remain within authorized levels;
 - Assists with the review of current and previous budget period commitments to ensure their validity to carry forward and cancel outstanding commitments not valid;
 - Where required, properly calculate and allocate shared operating expenses to applicable UN missions and agencies;
 - Take corrective actions on payment problems by analyzing problem, liaising with requester, budget owner, system Local Process Expert (LPE) other related parties as appropriate;
 - Run system queries/reports to obtain relevant work data/statistics;
 - Maintenance of the proper filing system for budget records and documents;
- 2. Supports knowledge building and knowledge sharing focusing on achievement of the following results:
 - Participation in the finance/budget related trainings;
 - Contribution and sharing of knowledge with team, knowledge networks and communities of practice.
- 3. Other tasks as assigned.

Competencies

Professionalism: Knowledge of, and ability to apply financial rules, regulations and procedures in the UN environment. Knowledge, skills and ability to extract, interpret, analyse and format data across the full range of finance and budget functions, including programme development and database management, claims and treasury operations. Ability to identify and resolve data discrepancies and operational problems. Shows pride in work and in achievements; demonstrates professional competence and mastery of subject matter; is conscientious and efficient in meeting commitments, observing deadlines and achieving results; is motivated by professional rather than personal concerns; shows persistence when faced with difficult problems or challenges; remains calm in stressful situations. Commitment to implementing the goal of gender equality by ensuring the equal participation and full involvement of women and men in all aspects of work. Teamwork: Works collaboratively with colleagues to achieve organizational goals; solicits input by genuinely valuing others' ideas and expertise; is willing to learn from others; places team agenda before personal agenda; supports and acts in accordance with final group decision, even when such decisions may not entirely reflect own position; shares credit for team accomplishments and accepts joint responsibility for team shortcomings. Planning and organizing: Develops clear goals that are consistent with agreed strategies; identifies priority activities and assignments; adjusts priorities as required; allocates appropriate amount of time and resources for completing work; foresees risks and allows for contingencies when planning; monitors and adjusts plans and actions as necessary; uses time efficiently.

Education

High school diploma or equivalent. Technical or vocational certificate in accounting, finance, budget or related fields is a requirement.

Work Experience

At least five (5) years of progressively responsible experience in the field of accounting and finance is required. Experience in budgeting processes and reporting is highly desirable. At least one year experience in an international organization is highly desirable.

Languages

Fluency in English is required;

Other Skills

Experience in the usage of computers and office software packages (MS Word, Excel, etc.) is required. Experience working with an ERP/SAP system is highly desirable.

Assessment Method

Short-listed applicants may be evaluated through a competency-based interview and/or other assessment methods.
